

銘傳大學教師專利獎勵辦法

Ming Chuan University Procedures for Encouraging Faculty members to Apply for Patents

中華民國 104 年 12 月 7 日第 303 次行政會議通過

Passed and revised at the 303th Administrative Council Meeting on December 7th, 2015

第一條 設立宗旨

為獎勵本校專任教師獲得研發成果專利權，特訂定本辦法。

Article 1 (Mission)

Ming Chuan University Procedures for Encouraging Faculty Members to Apply for Patents (herein refer to as these procedures) were established to award faculty members whose research achievements are recognized in the patent registration process.

第二條 獎勵資格

Article 2 Award Eligibility

一、專利證書所記載之第一順位發明人或創作人需為本校專任教師。

Patent certificates must indicate that MCU faculty members are first on the list of creators or inventors for the patents.

二、獎勵案件之專利權人須為本校。

MCU is authorized to obtain the right to those research achievement patents.

三、獎勵前一年度期間內所取得之專利，且受獎人需於受獎年度時仍專任在職。

In order to receive awards for the patents that are attained within the previous year, award recipients must be employed at MCU during that period.

第三條 獎勵項目及金額

Article 3 Award Amounts and Titles

一、發明專利獎勵：專任教師之研發成果，經向智慧財產權專責機關申請，並經審核獲得中華民國及其他地區（不含歐洲各國、美國及日本）發明專利者，每件獎勵新台幣壹萬伍仟元整；獲得歐洲各國、美國、日本發明專利者，每件獎勵新台幣參萬元整。

Invention Patent Award: MCU faculty members who submit their research achievements to relevant intellectual property organizations for patent applications and then, upon being approved, successfully attain patent rights in the Republic of China and other regions (excluding European countries, USA and Japan) will receive NTD 15,000 dollars for each patent certificate. Those who successfully attain patent rights in European countries, USA and Japan will receive NTD 30,000 dollars for each patent certificate.

二、新型專利獎勵：專任教師之研發成果，經向智慧財產權專責機關申請，並經審核獲得中華民國新型專利者，每件獎勵新台幣伍仟元整；獲得歐洲各國及日本新型專利者，每件獎勵新台幣壹萬元整。

Innovation Patent Award: MCU faculty members who submit their research achievements to relevant intellectual property organizations for patent applications and then, upon being approved, successfully attain patent rights in the Republic of China will receive NTD 5,000 dollars for each piece. Those who successfully attain patent rights in European countries and Japan will receive NTD 10,000 dollars for each such patent.

三、設計專利獎勵：專任教師之研發成果，經向智慧財產權專責機關申請，並經審核獲得中華民國設計專利者，每件獎勵新台幣參仟元整。

Design Patent Award: MCU faculty members who submit their research achievements to relevant intellectual property organizations for patent applications and then, upon being approved, successfully attain patent rights in Republic of China will receive NTD 3,000 dollars for each such patent.

四、專利獎項比照發明人取得之專利項目為依據。

Awards will be based on the actual patents conferred.

第四條 審核方式與獎勵金發放

獎勵名單由創新暨產學營運處於每年十一月份彙整前一年度資料，提送本校「產學推動委員會」審議，經審議確定之獎勵名單簽核後發給獎勵金。

Article 4 Evaluation Method and Reward Distribution

The rewardee list for the previous year will be organized by Innovation and Industry-academia Collaboration Division in November annually. The list will be submitted to Academia-industry Research Promotion Committee for review. Upon being approved, recipients will receive the reward according to the list.

第五條 同一研發成果如獲不同國家專利者，除發明專利或相當於我國之發明專利外，以獎勵一次為限。

前項所稱相當於我國之發明專利俱以本校產學推動委員會之認定為準。

Article 5 The same research achievement that is approved for patent registration in different countries can only be rewarded once, excluding invention patent or equivalent to ROC invention patents.

Exclusions mentioned above regarding invention patent or ROC invention patents must be approved by MCU Innovation and Industry-academia Collaboration Division.

第六條 本辦法經行政會議通過，校長核定後公布實施，修正時亦同。

Article 6 Upon being approved by Administrative Council and the president, these procedures were announced and implemented. Any revision must follow the same procedure.
